### Product Description

The SIMPLEX series 3036 is available with the insert combination of TPE-mid / plastic. The grey TPE-mid insert (series 3203) allows for an impact force that is comparable to the black rubber insert. The difference is that it will not leave any undesired black marring. The red plastic insert (series 3206) is hard and also oil and grease resistant. Made of cast iron, the housing comes with an integrated handle protection sleeve that provides for a high level of break resistance. Damping vibrations and shaped ergonomically, the high-quality wooden handle has a double coat of varnish in the grip area and is thus resistant to dirt. In line with the smart SIMPLEX principle, all components are replaceable and can be retrofitted. This translates to savings in both money and resources. This version is available in sizes ranging from D30mm to D60mm.

- Cast iron housing with integrated handle protection sleeve and excellent break resistance.
