#### Product Description

The SIMPLEX series 3103 is equipped with the TPE-mid insert on either side. This grey, medium hard insert (series 3203) allows for an impact force that is comparable to the black insert made of rubber composition (series 3202). The difference is that it will not leave any undesired black marring. The extra light aluminium housing with built-in handle protection sleeve allows the user to easily apply and control the right amount of impact force. This makes it a cinch to process materials that break easily. Damping vibrations and shaped ergonomically, the high-quality wooden handle has a double coat of varnish in the grip area and is thus resistant to dirt. In line with the smart SIMPLEX principle, all components are replaceable and can be retrofitted. This translates to savings in both money and resources. This version is available in sizes ranging from D30mm to D60mm.

- The extra light aluminium housing with built-in handle protection sleeve allows the user to easily apply and control the right amount of impact force (ideal of work on materials that break easily).
